



FINANCIAL STATEMENTS HIGHLIGHTS OF LOCAL GOVERNMENT UNITS

FISCAL YEAR 2007

BALANCE SHEET

The Financial Statements include Balance Sheet and Statement of Income and Expenses. Balance Sheet shows the financial condition of agencies in terms of assets, liabilities and equity. The Consolidated Balance Sheet as of December 31, 2007 of Local Governments (80 provinces, 135 cities and 1,450 municipalities), showed assets of ₱479.11 billion, liabilities of ₱102.11 billion, deferred credits of ₱33.98 billion and equity of ₱343.02 billion. The highlights of the Local Government Units' financial condition are shown below.

1. ASSETS – ₱479.11 billion

Total assets of ₱479.11 billion posted a growth rate of 12.06 percent or ₱51.58 billion from last year's ₱427.53 billion. Fifty-four percent or ₱40.16 billion of the increment was on Property, Plant and Equipment. Current assets totaled ₱141.54 billion or 29.54 percent of the aggregate assets consisting of Cash – ₱77.73 billion, Receivables – ₱53.64 billion, Inventories – ₱7.49 billion, Prepayments – ₱2.1 billion and Other Current Assets – ₱574.39 million.

2. LIABILITIES AND DEFERRED CREDITS – ₱136.09 billion

Total liabilities reached ₱102.11 billion showing an increment of ₱13.54 billion or 15.29 percent from the 2006 level of ₱88.57 billion. Deferred Credits of ₱33.98 billion recorded an increase of ₱5.2 billion or 18.17 percent from the ₱28.78 billion reported in 2006. It consists of increases in Deferred Real Property Tax and Special Education Tax Income – ₱5.1 billion and Other Deferred Credits – ₱127.82 million. The LGUs with the highest amount of total liabilities are listed below.

3. EQUITY – ₱343.02 billion

Cash balance of ₱77.73 billion represents 54.92 percent of the total Current Assets broken down into Cash in Bank – ₱72.88 billion and Cash on Hand – ₱4.85 billion. Of the total Cash, ₱38.45 billion was shared by cities, about by a net income of ₱40.02 billion, positive adjustments of ₱15.81 billion in the beginning balance, negative adjustments of ₱20.6 billion by municipalities and ₱18.67 billion by provinces. The provinces, cities and municipalities with substantial cash at yearend are shown below.

Equity grew by ₱32.83 billion or 10.58 percent from last year's level of ₱310.19 billion. The increment was brought about by a net income of ₱40.02 billion, positive adjustments of ₱15.81 billion in the beginning balance, negative adjustments of ₱3.1 billion in prior years' transactions and transfer of completed public infrastructures and reforestation projects worth ₱19.89 billion to the registries.

STATEMENT OF INCOME AND EXPENSES

Statement of Income and Expenses shows the financial performance in terms of sources of income and expenses and items of resulting net income or loss from operations. For fiscal year 2007, the taxing and other revenue-raising powers vested to the Local Government Units (LGUs) under Republic Act No. 7160 resulted to a total income of P234.82 billion. To ensure and support, among others, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant, scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants, total expenses of LGUs reached P194.79 billion leaving a net income of P40.02 billion. The results of operations of the LGUs are highlighted below.

1. INCOME – P234.82 billion

Pursuant to the basic policy of local autonomy that LGUs can exercise the power to create their own sources of revenue and to levy taxes, fees or charges which shall accrue exclusively to their treasury, LGUs generated a total income of P234.82 billion. The total income is higher by P16.51 billion or 7.56 percent from last year's level of P218.30 billion. Shown below is the list of LGUs by unit which generated the highest and lowest gross income for the year.

Of the total income, 62.43 percent or P146.59 billion represents share from Internal Revenue Allotment (IRA). The ten LGUs which received the highest and lowest share of IRA from the National Government for 2007 is shown below.

2. EXPENSES – P194.79 billion

3. NET INCOME – P40.02 billion
