It is the physician who is "ghost faculties" bringing down the wrath of the National medical council [NMC]. The total number of contact hours is 30 (20 for ethics, 10 for law). In addition, students should be made aware of, medico-legal issues, such as patient abandonment, malpractice, and duties of care in emergencies. The bane of medical education is "Capitation fees" which are being illuminated by policies [3].

**Case 1:** A pregnant woman walks into a hospital complaining of stomach pain and the doctor conducted a sonography. The doctors took her sonography reports and call it an emergency, only to operate on her, do unnecessary stitches and extract money. This whole drama of "sonography" and "emergency" was needless and was done only to acquire money. Scary isn't it? [4].

**Case 2:** An 8-year-old boy died at Medical Center in August 2013. His liver and kidneys were donated for transplant without taking proper consent [5].

**Case 3:** A 16-year-old girl in an ICU battling for her life. Doctors thought it was a perfect time to snatch all the money from the parents and keeps on asking for blood and more money to do further treatment. Do you think parents will ever think twice in that situation?

**Case 4:** A magistrate court directed the police to investigate against a doctor after a woman complained that he had been practicing without a license for more than 25 years [6].

**Case 5:** AIIMS doctors did dialysis of a woman from Bihar after she came with a stomach-ache yet she was not found with any kidney-related issue, yet doctors did her dialysis.

Many more such cases we see in real life. Some may have experienced it while some did not but it exists in the real world [7].

These cases were taken from national newspaper reports that highlight the pathetic situation of some doctors who fall into some materialistic gain, over and above their limits of, “code of ethics”. Even in a covid pandemic, some doctors and healthcare professionals made “hay while the sunshine”. Healthcare professionals should work as multidisciplinary teams to provide healthcare for the population, all teams members should be ethical in meeting healthcare and any lapse in one would crumble the ethicality in the healthcare. Whistleblowers are necessary along with a stringent code of ethics for optimizing the ethical behavior of healthcare professionals.

### Research

Ethical principles are Violated in the area of research by healthcare professionals. This can be reviewed by unethical research conducted down the ages in various countries. It is human experimentation that violates the principles of medical ethics. Such practices include denying patients the right to informed consent, using pseudoscientific frameworks such as race science, and torturing people under the guide of research [8].

**Nazi Trials:** It became accomplished especially on Jews from throughout Europe within the awareness camps at some stage in World War II and the holocaust forcibly without consent for the procedures. Prisoners of the axis energy had been revealing to brutalities together with dual research on genetic mutation and bone, muscle, and nerve transplants at some stage in which sufferers had been now no longer furnished any anesthesia. After the battle those crimes are called “*Doctor’s Trials*” and those abuses caused the improvement of “*Nuremberg Code of Medical Ethics*”. During the Nuremberg trial, 23 Nazi docs had been subjected for unethical remedy of awareness camp inmates who had been frequently used as studies topics with deadly consequences [8-9].

**Tuskegee Syphilis:** This covered 399 inflamed African American guys and 201 uninfected African American guys and that they have been promised unfastened clinical remedy/care. This study endured from 1932-1972. Which received public popularity in 1972 and become blanketed with the aid of using John Heller of the related press later posted in the New York Times. The look ended quietly and suddenly [10].

**Guatemala Study:** In the US of Guatemala, researchers had been starting to introduce a lethal bacterium “*Treponema pallidum*”, or extra usually called Syphilis, to the residents with no forewarning or consent and had been unfolded to 1500 topics at the side of numerous different sexually transmitted infections (STIs). To underhanded pressure, the Guatemalan human beings without their knowledge, United States surgeon “John Charles Cutler” additionally took element in the Tuskegee Syphilis Study, which lasted for 40 years. He and his crew of scientists employed prostitutes who had been already inflamed with the sickness as their number one mode of transmission and the bulk of the focused topics protected susceptible populations, which includes sufferers from insane asylums, jail inmates, and Guatemalan soldiers. The closing intention of the Guatemala Syphilis Study become to decide the effectiveness of penicillin. However, in the technique of appearing this unauthorized medical trial, Cutler and the numerous different scientists violated a number of the very principles. Of the 1500 uniformed, involuntary topics that participated in the Guatemala Syphilis experiment, eighty-three, in the end, died from incorrect management of the sickness. Not till 2005, however, whilst Susan Reverby of Wellesley College become learning the Tuskegee take a look at had been the experiments at Guatemala discovered. Her uncovering of those unlucky activities brought about the publishing of “*Ethically Impossible*” a

document with the aid of using the Presidential Commission for the Study of Bioethical Issues which became launched in 2011. In October of 2010, President Obama issued a proper public apology on behalf of the USA Government for the happenings in Guatemala [11].

**Willowbrook Study:** It became performed through Saul Krugman and Joan P Giles of the New York School of Medicine, Willowbrook became selected because of the endemic nature of hepatitis in the group. This test could encompass serum samples that can be amassed from the youngsters before the contamination, additionally in the course of the incubation period, and after the contamination became cured, and overall, seven hundred of the scholars participated. They additionally deliberately gave hepatitis to mentally retarded youngsters which have been housed at Willowbrook country college in Staten Island, New York trying to tune improvement of viral contamination [12]. The observation started in 1956 and lasted for approximately 14 years. The researcher additionally desired to decide the effectiveness of gamma globulin injections as safety in opposition to hepatitis. They justified their planned infections and exposures by putting forward that for the reason that there has been an excessive charge of contamination with the group it became almost inevitable that the youngsters could grow to be infected [13]. Further questions of the moral situation were raised as it became youngsters who have been a part of the observe, with many contending that simplest therapeutic, and now no longer scientific, clinical experiments should use youngsters, at the same time as others contend that mother and father have been blackmailed into consenting [12].

**Deaths in a trial of the HPV vaccine:** The loss of life of ladies who had been part of a Human Papilloma Virus vaccine trial has raised an alarm approximately the character of studies in India in addition to the cost connected via way of means of the kingdom to the lives of its citizens. The trial become being performed in Andhra Pradesh and Gujarat via way of means of the NGO PATH with the guide from the Indian Council of Medical Research and neighborhood fitness authorities. When the authorities stopped the rigors, 3 doses had already been administered to 30,000 participants, basically tribal ladies, elderly among nine and 14. The trial became for cervical most cancers screening approach and the girls who died had been a part of a manage organization saved without screening to examine dying charges in unscreened populations. It is a well-set up the truth that any form of cervical screening reduces the occurrence of most cancers. Yet nearly 140,000 girls within the manage arm of the trial had been now no longer screened. After a criticism became made to it, America Office for Human Research Protections (OHRP) decided that the girls had been now no longer given good enough statistics to offer knowledgeable consent. Those who had been arguing that the trial became unethical additionally say it violated the global moral tips on scientific research, the Helsinki Declaration's tips, which without a doubt country that "the benefits, risks, burdens and the effectiveness of a brand new intervention have to be examined towards the ones of the pleasant modern tested intervention" [15]. Even Indian Council of Medical Research (ICMR) tips stipulate that a placebo may be used while the disorder is self-restricting or while no tested preventive, diagnostic, or healing approach exists for it [15].

**Streptokinase trials in India:** Unethical elements include the groups had overtly carried out unlawful section III scientific trials of recent capsules on unaware sufferers and had carried out mistaken scientific trials without permission from the Genetic Engineering Approval Committee (GEAC) which made 8 sufferers dead. Shanta Biotechnics denied the allegations. Litigation changed into filed through the Delhi-primarily based NGO Aadar Destitute and Old People's home. In March 2004, the SOMO briefing paper on ethics in scientific trials eight Examples of unethical trials Supreme Court of India showed that the rigors have been unlawful [16].

**Covid related ethical issues in India:** Multiple fitness corporations in India together have referred to as for research into allegations of moral violations all through a medical trial of a covid-19 vaccine evolved collectively via way of means of India's Bharat Biotech and the Indian Council of Medical Research. Responding to the allegations, Bharat Biotech stated in an announcement that the trial is in complete compliance with "appropriate medical exercise suggestions and all regulatory provisions that practice to the behavior of medical trials in India." The enterprise additionally stated Indian suggestions offer for repayment to individuals for the journey to the trial web page and the everyday salary misplaced due to their participation. ### **Instances of Ethics transgression across the globe**

#### **Unethical Human Experimentation**

It is human experimentation that contravenes the principles of medical ethics. Such practices include denying patients the right to informed consent, using pseudoscientific frameworks such as race science, and torturing people under the guide of research [18].

**Involuntary Sterilization in Nazi Germany:** The earliest acts via way of means of Adolf Hitler after the Reichstag Fire Decree and the Enabling Act of 1933 gave him de facto prison dictatorship over the German country become to by skip the Law for the Prevention of Hereditarily Diseased Offspring in July 1933. This regulation is signed via way of means of Hitler himself, and greater than two hundred eugenic courts had been created distinctively for this regulation. Under it, all medical doctors in the Third Reich had been required to check in any sufferers of theirs who had been deemed intellectually disabled, characterized mentally ill (along with schizophrenia and manic depression), epileptic, blind, deaf, or bodily deformed, and a steep economic penalty become imposed for any sufferers who had been now no longer well reported. Each case is taken after which provided in the front of courtroom docket of Nazi officers and public fitness officials who could assessment their scientific records, takes testimony after which will determine step by step whether or not or now no longer order a sterilization operation. The sterilization software went on till the battle started, with approximately 600,000 human beings sterilized, and until the

When the difficulty of “obligatory sterilization” became added up on the Nuremberg trials after the battle, many Nazis defended their movements had been counting the number of reality had been copies from the United States and that they had taken suggestions from them. MCC head Helen Rees denied that the authorities had placed a strain on the council in making its selection. She defined the timing of occasions as “serendipitous” [20].

**Organ Trafficking:** It holds a critical place with a transnational organized crime group due to high demand and relatively low rates of law enforcement.

**China:** The world's maximum populous the USA is likewise at the pinnacle for transplants however recently because of tightened guidelines may also alternate this. It was given banned in July 2006 and around 2007 stated it might limitation for foreigners and prioritize ill Chinese.
