



QUALIFICATION SYSTEM – GAMES OF THE XXXII OLYMPIAD – TOKYO 2020

Boxing

Due to the suspension of the IOC recognition of AIBA, all aspects of all boxing competitions, including but not limited to any and all qualifying competitions or events for or at the Olympic Games Tokyo 2020 shall be organised and operated under the authority of the IOC Executive Board. The Executive Board has created a special taskforce with the mandate to organise and ensure the delivery of the qualification events for boxing and the boxing tournament at the Olympic Games Tokyo 2020 and also develop a Tokyo 2020 Qualification System for boxing. The enforcement of the regulations and the qualification criteria will be the responsibility of the Boxing Task Force, the respective national federations of the sport and the NOCs in the fields of their respective responsibilities.

3. Type of Allocation of Quota Places:

The quota place is allocated to the athlete(s) by name.

C. ATHLETE ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter that is currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions). Only those athletes who comply with the Olympic Charter may participate in the Olympic Games Tokyo 2020.

Age Requirements:

- For Olympic Qualification Events taking place in 2020, athletes must be born between 1 January 1980

and 31 December 2001.

- For Olympic Qualification Events taking place in 2021, athletes must be born between 1 January 1980 and 31 December 2002.
- For the Olympic Games Tokyo 2020, taking place in 2021, athletes must be born between 1 January 1980 and 31 December 2002.

Additional Eligibility Criteria:

To be eligible to participate in the Olympic Games Tokyo 2020 all athletes (including Host Country and Tripartite Invitation Places) must:

- Participate in at least one (1) of the Olympic Qualification Events organised by the Boxing Task Force. Should the athlete not be able to participate in at least one (1) of the Olympic Qualification Events organised by the Boxing Task Force due to postponement or cancellation of the event, the athlete must be ranked in the BTF Ranking List per weight category (see Appendix) as of 29 June 2021 in the respective weight category with points calculated from at least two (2) events. The BTF Rankings are established using international on-field results from 1 January 2017 to 14 June 2021 including the BTF Olympic Qualification Events. The BTF Ranking per weight category can be found [here](#) and will be updated after the European Olympic Qualification Event Phase 2 and the Americas Olympic Qualification Event.
- Enter in the same weight category at the Olympic Games in which the athlete obtained the quota place; and
- Be examined and cleared to box by a Physician, acting under the responsibility of their respective NOCs and NFs, before (i) each Boxing Olympic Qualifications Event and/or (ii) the Olympic Games Tokyo 2020 as per the medical requirements set forth in [\[link\]](#).

Entry process for Qualification Events:

All athletes shall be entered by their respective NOC and NF in accordance with the 'Tokyo 2020 Boxing Task Force - Event Regulations' [\[link\]](#) and comply with all abovementioned criteria.

D. QUALIFICATION PATHWAY

QUALIFICATION PLACES

Quotas which are allocated from the Continental Olympic Qualification Event through competition takes precedence over quotas which are allocated from the BTF Rankings.

HOST COUNTRY PLACES

The Host Country is guaranteed a total of up to six (6) Host Country Places.

These places are only available in the case that the Host NOC does not obtain any qualification places via the Asian/Oceanian Olympic Qualification Event, with a maximum of one (1) quota place per weight category and subject to the quota distribution as per Table 1 and Table 2 respectively, subject to the athlete meeting the Athlete Eligibility Criteria as outlined in Section C.

Up to four (4) will be available in the men's weight categories with a maximum of one (1) Host Country place per weight category and respecting the maximum number of athletes per NOC, except for the Heavy (81 kg to 91 kg) and Super Heavy (91kg to +91 kg) weight categories where no places are available.

Up to two (2) Host Country Places will be available in the women's weight categories with a maximum of one (1) Host Country place per weight category, except for the Middle (69kg to 75kg) weight category where no places are available.

TRIPARTITE COMMISSION INVITATION PLACES

A total of five (5) Tripartite Commission Invitation Places will be available in the men's weight categories with a maximum of one (1) Tripartite Commission Invitation Place per weight category and respecting the maximum number of athletes per NOC, except for the Light Heavy (75 kg to 81 kg), Heavy (81 kg to 91 kg) and Super Heavy (91kg to +91 kg) weight categories where no places are available.

A total of three (3) Tripartite Commission Invitation Places will be available in the women's weight categories with a maximum of one (1) Tripartite Commission Invitation Place per weight category, except for the Welter (64 kg to 69 kg) and Middle (69kg to 75kg) weight category where no places are available.

On 1 October 2019, the International Olympic Committee will invite all eligible NOCs to submit their requests for Tripartite Commission Invitation Places. The deadline for NOCs to submit their requests is 17 January 2020.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

CONFIRMATION OF QUALIFICATION PLACES

*The Boxing Task Force will inform the respective NOCs of their allocated quota places through the Continental Olympic Qualification Event through competition within three days (3) of the conclusion of the respective qualification event.

Should the Continental Olympic Qualification Event through competition not able to be organised, the Boxing Task Force will inform the respective NOCs of their allocated quota places through the Continental Olympic Qualification Event through the BTF Ranking List on 14 June 2021.

The list of allocated quota places can be found in the "[Qualification System, Athletes Eligibility and Sports Entries](#)" section on the Boxing Athlete 365 website after the completion of the respective qualification event.

NOCs will have two (2) weeks to confirm to the Boxing Task Force if they wish to use the quota places obtained through a Continental Olympic Qualification Event as detailed in paragraph G. Qualification Timeline.

*In the case of the European Olympic Qualification Event, the quota places in the Men's Fly and Feather weight categories have been confirmed. Quota places will only be allocated to the Men's Light, Welter, Middle, Light Heavy, Heavy and Super Heavy weight categories and to the Women's Fly, Feather, Light, Welter and Middle weight categories.

NOCs will have two (2) weeks to confirm if they wish to use the quota places obtained through the pool of quota places from the World Olympic Qualification Event, as detailed in paragraph G. Qualification Timeline.

CONFIRMATION OF HOST COUNTRY PLACES

Further to the conclusion of the Asian/Oceanian Olympic Qualification Event, and in case the Host Country obtains less than the four (4) male and the two (2) female guaranteed quotas across any of the weight categories, then the Host NOC will need to confirm the boxers in the weight categories selected for Host Country Places by 28 March 2020, as detailed in paragraph G. Qualification Timeline. The total number of Host Country Places that can be selected are as follows:

- If the Host Country obtains one (1) male quota place, a total of three (3) male Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains two (2) male quota places, a total of two (2) male Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains three (3) male quota places, one (1) male Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains one (1) female quota place, one (1) female Host Country places can be selected respecting the maximum event specific quota.

F. REALLOCATION OF UNUSED QUOTA PLACES

REALLOCATION OF UNUSED QUOTA PLACES

Quotas which are allocated from the Continental Olympic Qualification Event through competition takes precedence over quotas which are allocated from the BTF Rankings.

If an allocated quota place obtained from a Continental Olympic Qualification Event through competition is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the next highest ranked athlete in accordance with Rule 16.5 of the 'Tokyo 2020 Boxing Task Force - Event Regulations' [\[link\]](#) at the respective Continental Olympic Qualification Event, in the respective weight category, respecting the criteria outlined in Section C.

If an allocated quota place obtained from a Continental Olympic Qualification Event through the BTF Rankings is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the next highest ranked athlete not already allocated a quota place from an NOC that has not yet obtain a quota place in accordance with the BTF Rankings in the respective weight category, respecting the criteria outlined in Section C.

If an allocated quota place obtained from the pool of quota places from the World Olympic Qualification Events is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the next highest ranked athlete not already allocated a quota place in accordance with the BTF Ranking List as of 14 June 2021 in the respective weight category, respecting the criteria outlined in Section C.

In the case where a quota from a Continental Olympic Qualification through competition is declined and the next highest ranked athlete in accordance with Rule 16.5 of the 'Tokyo 2020 Boxing Task Force - Event Regulations' [\[link\]](#) at the respective Continental Olympic Qualification Event, in the respective weight category, has already been allocated a quota from the BTF Rankings, the athlete will occupy the quota of the Continental Olympic Qualification Event through competition that was declined. The athlete's quota that was originally obtained through the BTF Ranking list will then be reallocated to the next highest ranked athlete not already allocated a quota place in accordance with the BTF Ranking List in the respective weight category, respecting the criteria outlined in Section C.

Rule 16.5 of the 'Tokyo 2020 Boxing Task Force – Event Regulations'

For Olympic quota reallocation purposes, the definition of "next highest ranked athlete" refers to the Boxer defeated by the Boxer who did not accept the quota place, or had it denied in the specific bout that determined the qualification.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Any unused Host Country Place(s), declined or not confirmed by the confirmation of quota places deadline will be reallocated to the next highest ranked athlete regardless of continent not yet qualified from an NOC that has not obtain a quota place in the respective gender and weight category from the BTF Rankings .

REALLOCATION OF UNUSED TRIPARTITE COMMISSION INVITATION PLACES

Any unused Tripartite Commission Invitation Place(s), declined or not confirmed by the confirmation of quota places deadline will be reallocated to the next highest ranked athlete not already allocated a quota place in accordance with the BTF Rankings as of 14 June 2021 in the respective weight category, respecting the criteria outlined in Section C.
