## **SECOND AVENUE SUBWAY - PHASE 1**

#### Scope:

- Tunnels from 92<sup>nd</sup> St to 63<sup>rd</sup> St
- Stations at 96<sup>th</sup> St, 86<sup>th</sup> St, 72<sup>nd</sup> St and 63<sup>rd</sup> St
- 63<sup>rd</sup> St Subway Connection
- Track & Systems from 105<sup>th</sup> St to 63<sup>rd</sup> St
- Service between 96<sup>th</sup> St & Brooklyn via Broadway Line

#### **Benefits:**


- Relieves Overcrowded Lexington Avenue line (86<sup>th</sup> St to Grand Central)
- Connects to existing system (Storage and Maintenance)
- Early use of Tunnel Section built in 1970's

## CONSTRUCTION LOOK AHEAD FOR 96<sup>TH</sup> STREET STATION AREA – for next 3 months

Major Operations in the next three months:

- Continue secant piles at Ancillary 2 (97th St)
- Begin work at Ancillary 1 (93rd St)
- Begin slurry wall
- Relocate bus stop from 99th to 97th St
- Daytime closure of 95th St west of 2nd Ave (sewer construction)

The West TBM ended its run just south of 65th St at 2nd Ave. The first TBM run (West) does not connect to the existing 63rd St station. That will be accomplished by East TBM run which will start later this spring.




Major Operations in the next three months:







#### **Controlled Rock Blasting and Removal**

- The safety of the public and our workers is the MTA's top priority.
- Controlled Blasting Plans have been designed by a Specialty Blasting Consulting Expert.
- The Blasting Plans have been approved by FDNY Explosives Unit.
- All blasting work is being monitored by FDNY Explosives Unit.





#### **Controlled Rock Blasting and Removal**

- Buildings adjacent to the blasting area are being inspected before this work begins by an independent engineer and specialty consultant with experience in old brick masonry.
- Blasting Vibration Monitoring Equipment has been installed in buildings within the blasting area.
- The allowable vibrations caused by controlled blasting have been set at levels that are lower than the standard for similar building types.

Major Operations in the next three months:

- Ancillary 2 (72nd St) demolition
- Continue blasting at 69th St & 72nd St shafts
- Begin installation of Rock Removal System












#### Lexington Avenue 63rd Street Station – Scope of Work

Major Operations in the next three months:

- Install geotechnical instrumentation
- Pre-construction survey
- Staging area setup at Plaza
- Set up of Maintenance and Protection of Traffic (MPT)







To improve the pedestrian experience and conditions for local businesses, we are implementing the following enhancements:

- Way finding signage for stores
- Replacement of bent/worn fencing
- Signage that advertises small businesses on the street side barriers
