# From the Desk of the Secretary

The furnace at the Temple has been restored to service. Our last Stated Communication was kept very short due to the cold weather and lack of heat. The local heating company threw their hands in the air and declared that they could not fix the problem. Our intrepid house committee contacted a Seattle firm that sent over a repairman to investigate. Yes, the furnace is old. Yes it is out of date. Yes it is repairable. In fact the technician had the necessary part in his tool bag. His assessment is that there is no reason we can't get many more years of use out of the furnace. There are also some upgrades that can be done to improve efficiency. Perhaps this is a case of a lemon turning into lemonaide. Congratulations to MWB Jimmy Reid and the house committee for seeing to this repair.

The preceding brings up another point. It is obvious that many of the systems (all?) in the temple are very old. The electrical system is a case in point. There are not enough outlets in many locations, and many of the ones we have are not of the sturdiness one would hope and expect from a modern electrical system. The house committee and Temple Board continue to attempt small upgrades where possible and affordable. Outlets are being added to the 2nd floor clubroom as an example. Despite those on-going efforts we have a long way to go, and we often have to "make do" with what we have.

Because of the press of getting dues cards into the hands of our members, an unusual number of notices were received regarding deaths of members of our lodge. I just received another; Bro Harold K Richardson actually passed away in December of 2004, but I was just notified by his son of his passing in AZ. I have just discovered that Brother Maurice Nelson passed away in 2003. Assuming that we will not have another short meeting, the following members will be memorialized: Bro. Curtis Belcher, Bro.
