NEK History Fair

Historical research was on display Tuesday, March 21, at the Northeast Kingdom History Fair, with 130 projects produced by over 250 students in grades six through 12 set up in the big arena at IROC in Derby. Students from North Country Union High School, Orleans Elementary, Glover Community School, Coventry Village School, Irasburg Elementary, and Brownington Central School participated in the fifth annual fair organized by the Old Stone House Museum.

The students arrived in the morning to set up their projects, and then gathered to listen to a thought provoking debate about the Death Penalty conducted by North Country Union High School students Kate Page, Alyssa DeMoritt, Matt Girard and Martin Rollins. Then the students went back to school, and the fair was open for public viewing. During the afternoon the judges arrived to evaluate the projects.

IROC donated the use of their arena for the day, and many volunteers contributed their time and energy to make the day a success. Boy Scouts helped set up the 62 tables and 200 chairs. Hostesses greeted people at the door and arranged refreshments during the day. Twenty-seven members of the community served as judges, interviewing the students when they arrived back at 6 PM. And the Brownington Homemakers served delectable cookies to the students and families during the evening.

A total of \$1300 in savings bonds was awarded to the students with the first and second place entries. Each received a \$50 savings bond, donated by area banks, organizations and businesses, to help fund future education expenses. In addition, IROC gave a day pass to every participant in the History Fair.

Quilt raffle 2006

Cathie Sheehan of Albany, Vt. has donated a beautiful quilt for the Old Stone House Museum's **2006 QUILT RAFFLE.** Tickets are \$2 each or 10 for \$10.

This queen-sized quilt, *Climbing to the Stars*, was inspired by two classic quilt blocks. In the center of the quilt are blocks based on the Jacob's Ladder design; these blocks climb to the border of Variable Star blocks, all of the stars being in shades of red.

Climbing to the Stars quilt is reversible, with the back being larger Jacob's Ladder style blocks with a border of fabric strips.

This quilt is machine washable in cold water, gentle cycle, using Woolite or Quilt Soap and Color Catcher. It

can be dried in the dryer or dried flat out of direct sunlight. *Climbing to the Stars* was designed and made by Cathie Sheehan and machine quilted by Sherry Greenwood.

The drawing will be held on October 15, 2006, the last day the museum is open. Annual Meeting

In a radical departure from tradition, the Annual Meeting of the Orleans County Historical Society will be held on Sunday, July 9 this year, not on Old Stone House Day. The meeting will be at the Brownington Congregational Church and will begin at 1 PM with a talk by Howard Coffin of Montpelier.

Mr. Coffin is well known for his work on the Civil War and is a popular speaker. His books include *Full Duty: Vermonters in the Civil War; Nine Months to Gettysburg; The Battered Stars;* and, with Jane Curtis and Will Curtis, *Guns Over the Champlain Valley: A Guide to Historic Military Sites and Battlefields.* Mr. Coffin's talk, Vermont and Human Freedom, will include slavery, the Vermont Constitution, the abolition movement, and 19th century Vermonter's views on race. He will be available after the talk to sell and sign his books. This program is supported in part by the National Endowment for the Humanities and the Vermont Humanities Council. It is free and open to the public.

After the talk, the Historical Society's business meeting will be called to order and will include reports on the past year, election of trustees and officers for 2006-2007, and discussion of future plans. We hope that by separating the annual meeting from Old Stone House Day, when many of our most active members are busy in the museum and around the grounds, more of our members will be able to participate in the meeting. Volunteer Tea

The Old Stone House Museum's annual Volunteer Tea will be held on Tuesday, June 6 at 3 PM at the Brownington Grange. All museum volunteers are cordially invited to attend.

The speaker will be Jeanne Brink of Barre, Vermont. Ms. Brink draws upon her Abenaki family history and experience to serve as a Native American consultant to schools and organizations. She is a traditional basketmaker and coauthor of a Western Abenaki language guide. Ms. Brink holds a master's degree in Native American Studies and she will speak on the history and culture of the Western Abenaki. Her topics include the Abenaki way of life, the importance of elders and children, the environment, and the continuance of lifeways and traditions.

Collectors Fair

Over 20 collectors displayed their collections of everything from butter boxes to World War II memorabilia in the Orleans Elementary School Gym on Sunday, February 19. Many of the collectors are members of the Antique Gas and Steam Engine Association, and look

forward to this indoor winter get-together to catch up with each other, and admire a whole new batch of stuff.

Other local collectors joined them, with previously unseen collections to be admired. Ricky Mallary from Westmore brought in a collection of oilcans he inherited from his grandmother. Ricky's wife, Nancy, served food to the crowd, and was also a big hit with her homemade sauerkraut and pickles.

Folks of all ages wandered through the gym throughout the day, looking at the variety of stuff and engaging in conversation with the collectors, who are quite a talkative bunch. Some things were for sale, like old board games, puzzles and marbles. Most were treasures on exhibit only, like the array of chainsaws from the earliest to the more modern, and a tiny working steam engine.

Danny Gore (alias Norm Lewis) brought information and propaganda about Vermont's unincorporated gores. Fred Webster of Coventry displayed some antique furniture built locally. Chet and Kathy Carpenter of Newport exhibited their albums of old postcards.

Bob Williams of West Burke, who is a member of the Gas and Steam Engine Association, helps to organize the Collectors Fair every year. The Orleans Elementary School donates the use of their space, and custodian Mike Tanguay helps us set up the tables.

It was a fun day, and a wonderful opportunity to hang out with some of the great old characters who make Vermont such a special place.

Big band benefit dance set for June 24

Brush up on your waltz and put on your dancin' shoes. The Old Stone House Museum is holding a Big Band Dance at the Irasburg Town Hall on Saturday, June 24, from 8 until midnight. The 19-piece St. Johnsbury Big Band 2006 will be bringing the classic music of the 30s and 40s back to life for our museum fund-raiser.

It's a BYOB affair, with snacks and mixers provided. The cost is \$25 per couple, or \$15 per person. World War II vets and their wives or widows get in for World War II prices.

Many of the Big Band greats, like Duke Ellington, Tommy and Jimmy Dorsey, Woody Herman, Cab Calloway, and Tony Pastor with Betty and Rosemary Clooney have played in Orleans County. They took a break from the Boston/Montreal train to stop off in Newport, and play at the old International Club, which boasted the largest dance hall in New England. Emily M. Nelson describes the International Club in her book *Frontier Crossroads, the Evolution of Newport, Vermont.*

The building, which was located near Blanchard Avenue in Newport, measured 220 feet long and 60 feet wide, and had a polished maple dance floor that could accommodate up to 2,000 people. It drew an audience from a 150-mile radius on both sides of the border, and hosted many visiting and local bands from 1937 until it was torn down in 1953. The crowds diminished after World War II, and the big hall was closed, with only the lounge used for dances and parties. Owners Marjorie and Theron Meader took apart the dance floor themselves, because they knew no one else would be so careful with it.

Here's your chance to dance to those big band sounds again. If you've never had the opportunity to dance to Big Band music, come give it a try. If you don't want to dance, just come to hear the music and visit with friends, in a beautifully restored historic town hall.

April Workshops
